Scope of Work

Applications are sought from current UCSF Faculty (All Schools) for the position of Faculty Director, Pilot Awards program of the Clinical and Translational Science Institute (CTSI). A CTSI workforce that is diverse, inclusive, and equitable is an important part of our mission and critical to our success. We welcome and encourage applications from faculty with lived and/or professional experience in communities that are excluded from research and who center equity and justice in their work. All academic ranks are encouraged to apply.

This is an internal UCSF search.

The Faculty Director is responsible for oversight and direction of the CTSI Pilot Awards Program, which provides intramural funding to seed novel research in CTSI's priority areas, including support for faculty and trainees underrepresented in medicine, early career investigators, and research focused on NIH priority areas. The Pilots Program is supported by a strong staff team that works independently but collaboratively with the Faculty Director to administer awardee grants and carry out program objectives.

The Faculty Director, Pilot Awards Program reports to the Director, CTSI.

This is a part-time 5% (up to NIH cap) position.

The specific priorities of the Faculty Director will be determined by the incumbent in collaboration with the CTSI Director and staff leadership. General responsibilities will include:

- Providing leadership to the Pilots program to oversee the selection and administration of intramural grants through the <u>UCSF Research Allocation Program</u> (RAP) (typically 8-10 awards per year).
- Collaborating with CTSI leadership and program staff to set funding priorities within the restrictions of federal policy.
- Advising program staff on issues of applicant or project eligibility, and other requests requiring faculty input.
- Representing CTSI at the Research Allocation Program Executive Committee, working with other granting agency leaders to make policy, strategy and operational decisions.
- Developing new initiatives and funding opportunities in response to CTSI and campus priorities and the needs of the research community.

- Participating in CTSI Leadership Council monthly meetings, as well as other CTSI activities and meetings as requested.
- Participating as key personnel on the CTSA grant, including regular engagement with CTSI leadership and institutional stakeholders in the development, direction, and evaluation of overall CTSI activities.

Criteria for appointment:

- Assistant, Associate or Full Professor rank.
- Ladder Rank, In Residence, Clinical X, Health Sciences Clinical or Adjunctseries appointment.
- DNP, PhD, MD, DDS, Pharm D, DPTSc, DSc, or equivalent.
- Willingness to participate in and work collaboratively with CTSI and Pilot program faculty and staff by attending regular CTSI meetings and other activities as requested.
- Familiarity with RAP grants, either as a grantee, applicant, reviewer, or funder (preferred)
