# 2009 University Community Partnerships Celebration and Research Partnership Award

#### **A Lively Celebration**

On October 22, 2009, University Community Partnerships (UCP) marked its first Partnerships Celebration event with an evening of food, music and awards at the UCSF Milberry Conference Center.

What is UCP? Executive Vice Chancellor and Provost, A. Eugene Washington, MD, MPH, convened a Community Partnerships Task Force in July 2004, which resulted in the creation of the UCP office and UCP

Council in the spring of 2006. The purpose of the office is to coordinate the many existing partnerships between UCSF-affiliated individuals/groups and San Francisco-based community organizations as well as to facilitate new partnerships that address health inequities. UCP serves as a bridge between UCSF and the community, emphasizing partnerships that value and respect the assets and diversity of both. One of its signature programs is the Grants Program, which provides funding to UCSF-community partnerships that address health inequities in some of San Francisco's most vulnerable communities.

UCP Council co-chairs Dixie Horning of the UCSF National Center of Excellence in Women's Health and Lynda Boyer-Chu, RN, MPH, of the San Francisco Unified School District presided over the celebration, which officially introduced UCP to the UCSF campus and our communities and gave attendees and awardees the opportunity to network with one another. The evening also featured an invigorating performance by "Taiko Sisters", a Japanese Taiko drum ensemble (featuring Boyer-Chu in yet another impressive role). The event gave UCP and its council members the opportunity to showcase the many partnerships created between UCSF and San Francisco's communities.

Among the guests at the well-attended event were UCSF's Chancellor, Sue Desmond-Hellmann, MD, MPH, Sue Carlyle, MD, PhD, Associate Dean at san Francisco General Hospital, Vice Provost Student Academic Affairs Joseph I. Castro, PhD and several deans from the various professional schools and division chairs. San Francisco Health Commissioner Steven J. Tierney, EdD, and prominent community leaders were also present. "UCP is a critically important initiative at UCSF. It is at the forefront of our institution's efforts to serve the community", the Chancellor noted as she addressed the audience. "Tonight's celebration marks an important milestone for UCP", added UCP's faculty co-director Naomi Wortis, MD.

#### **Research Award**

The heart of the evening's celebration was an awards presentation for exemplary University and community partnerships. *Research* was among the five focal areas in which awards were presented. **The Kellogg Health Scholars Program** develops new leadership in the effort to reduce and eliminate health disparities and to secure equal access to the conditions and services essential for achieving healthy communities. Through this two-year post doctoral fellowship program, scholars gain:

- competence to undertake research adding to our knowledge about the nature of social disparities in health and about interventions to reduce those disparities,
- · capacity to partner with communities in carrying out research and building policy advocacy, and
- skills to inform and support policy makers who seek to reduce and eliminate health disparities.

The program consists of two tracks at eight different training sites. The Community track highlights community-based participatory research (CBPR), and relationships between academic health disparities research and public health practice in communities. The Multidisciplinary track highlights a multidisciplinary approach to studying the determinants of health inequalities and inequities. Both tracks emphasize the translation of research to policy.

Sixteen individuals will be selected for the 2010-2012 fellowship cycle - eight in the Community Track and eight in the Multidisciplinary Track. Each fellowship will provide a stipend of \$63,000 in the first year and \$64,000 in the second year, and an annual research fund and other benefits.

Applications are due Wednesday, December 2, 2009, 5:00 p.m. Eastern. ONLY online applications are accepted.

The Robert Wood Johnson Clinical Scholars Program is accepting applications for the 2011-2013 cohort.

The Robert Wood Johnson Foundation Clinical Scholars program fosters the development of physicians who will lead the transformation of Americans' health and health care. These future leaders will conduct innovative research and work with communities, organizations, practitioners and policy-makers to address issues essential to the health and well-being of all Americans.

Program highlights include:

- leadership training;

#### **Bridging Clinical Scholarship and Community Scholarship**

The Robert Wood Johnson Clinical Scholars Program has supported a special supplemental issue of the *American Journal of Preventive Medicine* dedicated to community-based participatory research (CBPR).

#### The Women's Health Research Network (WHRN)

WHRN has published four primers focused on key areas and innovative approaches in girls' and women's health and gender and health research. The latest WHRN Primer, *Our Common Ground: Cultivating Women's Health Through Community Based Research*, is now available online.

#### International Journal of Prevention Practice and Research (IJPPR)

IJPPR is a new peer-reviewed journal that publishes high quality articles reporting the development and results of community-driven prevention programs, innovative community/campus partnerships that seek to prevent or mediate health compromising behaviors, community-engaged research that creates tangible products or directly translational results, or other prevention practice and research projects developed with and for communities. The goal of IJPPR is to further scientific discoveries that protect population health by fostering academic and community discourse across the spectrum of community-based prevention practice and research. Community involvement in the preparation of articles is required for publication.

The peer-reviewed journal **Progress in Community Health Partnerships: Research, Education and Action (PCHP)** will now be indexed in MEDLINE. Also known as "the journal of CBPR published by Johns Hopkins University Press," PCHP's mission is to identify and publicize model programs that use community partnerships to improve public health, to promote progress in the methods of research and education involving community health partnerships, and to stimulate action that will improve the health of people and communities.

## 7. Other Resources & Opportunities

Group Health Research Institute and its partners - the University of Washington, Institute of Translational Health Sciences, Duke Translational Medicine Institute, and Wayne State University - have developed a new website to help researchers create and sustain successful multisite research collaborations, including those involving community-academic partnerships. The project team created the site to enhance the efficiency of

research from start to finish, including developing research networks, launching and managing projects, and sharing study results or other products such as data sets, tools, and training resources.

The website was developed as part of a project known as **PRIMER**, or Partnership-driven Resources to IMprove and Enhance Research. PRIMER was awarded to the Institute for Translational Health Sciences (ITHS) at the University of Washington by the National Center for Research Resources of the National Institutes of Health. Read the complete press release about this resource.

The Foundation Center announces the beta launch of an online database of **Tools and Resources for Assessing Social Impact (TRASI)**. TRASI contains a comprehensive listing of 150 approaches to measuring and analyzing social impact for programs and investments. Authored by a range of organizations, including social investors, foundations, NGOs, microfinance institutions, and others seeking social change, these resources range from off-the-shelf tools and concrete methodologies to generalized best practices. In consultation with the respective organizations and authors of these resources, the authors have classified the approaches in TRASI along 18 categories. TRASI is scheduled to launch officially in the spring of 2010. If you are interested in participating in a beta test of TRASI or in receiving more information at the time of launch, please sign up here.

The National Cancer Institute has made available online the **Health Disparities Calculator** (HD\*Calc), statistical software that generates multiple summary measures for evaluating and monitoring health disparities. It can be used either as an extension of SEER\*Stat, which allows users to import Surveillance, Epidemiology, and End Results (SEER) data or on its own with other population-based health data, such as that from the National Health Interview Survey. The intended audience for HD\*Calc includes anyone interested in health and cancer-related disparities, as well as those interested in learning about summary measures of health disparities.

The public comment period for the **National Cancer Institute (NCI) Advocates in Research Working Group** (ARWG) final recommendations is open until November 30, 2009. The ARWG has proposed comprehensive recommendations on the most effective ways to engage individual advocates in NCI activities. The recommendations focus on:

- 1. Recruitment of individual advocates for NCI activities
- 2. Assessment and matching of individual advocates to NCI activities
- 3. Training of individual advocates and NCI staff to prepare for a research advocacy engagement
- 4. Facilitating the engagement process
- 5. Evaluating and tracking advocacy involvement
- 6. Retaining research advocates and NCI staff and promoting advocate involvement in NCI activities
